# Scope and content:

Fonds consists of records created and accumulated by the family of Myrtle and Ernest Webb.

Textual records consist of diaries written by Myrtle Webb from 1924 to 1954. Also includes newspaper clippings found among diary entries, as well as an accreditation for Ernest Webb for the Office of Commissioner.

Artifact consists of a beaded clutch bag that belonged to Myrtle Webb's cousin, Lucy Maud Montgomery.

# **Biographical sketch:**

Myrtle L. K. Macneill was born on August 2, 1883, in Havelock, New Brunswick, to single mother Ada Macneill from Cavendish, PEI. Myrtle Macneill was thirteen years old in 1896 when she moved to the farm that would become known as Green Gables in Cavendish, PEI, with her mother, Ada. They returned to help care for the 140-acre farm of Ada's elderly aunt and uncle, as well as siblings Margaret and David Macneill.

Ada Macneill married and moved to a nearby community a few years later, but Myrtle stayed at the Macneill farm. During this time, Myrtle became good friends with her cousin Lucy Maud Montgomery, who, having been away at university and teaching the previous few years, now lived just half a kilometer down the road.

When visiting family in O'Leary, PEI, Myrtle met farmer Ernest Cecil Webb (born in O'Leary on December 3, 1880). In 1905, Myrtle and Ernest married on the Macneill farm in Cavendish. The newlyweds moved to O'Leary for a time but returned in 1909 to look after David and Margaret again – this time in return for ownership of the farm.

Myrtle and Ernest Webb had five children: Marion ("Peggy"), Keith, Anita ("Neta"), Lorraine ("Waine"), and Pauline ("P.J.").

Ernest died on May 17, 1950, and Myrtle died on February 11, 1968. They are buried together in the Cavendish Community Cemetery in Cavendish, PEI.

### Biography:

The diaries contain entries, the majority of which are written in pencil, to such things (but are not limited to) as: the weather and natural events; day-to-day life on the farm and in the farmhouse; PEI news and events; church activities; local groups and organizations; births, deaths, and marriages in the local area; local dances and entertainment; visitors to the Webb farm; family activities and hobbies; as well as family sickness and ailments.

The diaries also contain entries documenting Myrtle Webb's relationship with her cousin Maud (Lucy Maud Montgomery), and the process of the Webb family farm becoming part of Canada's National Park.
